Learning Objectives for Workshop:

- * Identify characteristics of farming with a disability and identify available AgrAbility services.
- * Identify traits of the farm culture.
- * Identify hazards and risks associated with farming/ranching to better facilitate effective and relevant treatment interventions.
- * Identify occupational performance barriers on the farm/ranch and develop strategies to eliminate them for the farmer with a disability.
- * Discuss a farmer's decision to pursue his profession and work with him/her to return to or continue farming.
- Assess client needs through interview, observation and clinical measurements.
- * Identify resources available to assist farmers with disabilities to continue farming.
